WiN Sweden and WiN Global warmly invite you to participate in the 20th WiN Global Annual Congress which will take place in Kalmar, Sweden. The Congress also marks the start of a year of celebrations to mark WiN Global's 20th anniversary.

1. Congress Venue

The Congress will be held at the renovated, renaissance Kalmar Castle, in the city of Kalmar. The castle's history dates back over 800 years. In the 1300's, Kalmar was one of Sweden's most important cities. Kalmar Castle was the site of the signing of the Union of Kalmar on July 20th, 1397, which joined all of the Nordic countries under a common ruler. This legendary castle is a fitting location to host the 2012 WiN Global Congress.

There are many international flight connections via Stockholm Arlanda Airport to Kalmar Airport. There are also daily flights from Stockholm's smaller airport, Bromma Airport, to Kalmar Airport. There is a limited availability on weekends, and we therefore recommend that you book your flight well in advance.

Kalmar Airport is about 10 minutes drive by taxi from the centre of Kalmar. There is also a bus from the airport to the centre of Kalmar. Note: credit cards are not accepted on the bus and the ticket price is approximately SEK 25.

Flights are also available to two other airports that are close to Kalmar: Växjö Airport and Oskarshamn Airport.

You can also travel by train from Copenhagen, Denmark to Kalmar, Sweden. The journey takes 3 to 4 hours.

4. Congress Theme

The Congress will address the theme “Safety in the Nuclear Lifecycle: From Design to Disposal”.

Two sub-themes have already been identified: Sub-theme A: Safety in New Build and Operation and Sub-theme B: Safety in Decommissioning and Waste Management. There will be keynote speakers for the theme and for each sub-theme as well as parallel sessions.

5. Call for Papers

We look forward to receiving abstracts for oral presentations or posters.

Presentations or posters must address one of the following topics:

- ❖ New Build
- ❖ Operational Safety
- ❖ Decommissioning
- ❖ Waste Management

We particularly encourage oral presentations or posters that take the following into account:

- ❖ New Build: The industry is experiencing severe challenges. A focus on the future of the industry, new technical solutions, new types of reactors et cetera would be of interest.
- ❖ Operational Safety: Proactive work with safety in a long-term perspective addresses the central theme of the Congress.



- ❖ Decommissioning: Solutions to back-end management differ considerably between different countries. Your experience concerning solutions for dismantling NPPs and other nuclear facilities would be valuable.
- ❖ Waste management: Challenges and solutions with regard to both technical and public acceptance are a growing area of interest worldwide.

Instructions to Authors

Abstracts (a short overview) must be provided for both for oral presentations and posters. The abstracts must be in English and no longer than 400 words. Oral presentations may not exceed 15 minutes. More information on the detailed requirements for posters will be posted on the Congress website later on.

All presentations and posters should be at a technical level that everyone at the Congress can understand. Speakers and poster authors should be prepared to answer questions from the public. If the number of contributions regarding oral presentations exceeds the maximum allowed number of presentations, contributions will be subjected to a selection process. Speakers will then be notified whether or not their oral presentation has been accepted.

The Programme Committee reserves the right to determine the scheduling of presentations.

This tour will take you to a royal island with a long history and unique flora and landscapes. You will see windmills, hundreds of limestone walls, linear villages, grazed landscapes, cultivated landscapes and coastal landscapes. The tour begins with a short walk where you will see unique orchids flowering. This will be followed by a guided tour by bus to view exhibitions of world-famous Swedish glass and beautifully displayed ceramics, with a chance to do some shopping. You will then enjoy lunch at a restaurant of good reputation, followed by a short visit to the Royal parks and finally a tour of the World heritage site of southern Öland.

Option 1:

DAY TRIP TO SKB'S AND OKG'S NUCLEAR FACILITIES, THURSDAY, 31st MAY, 2012 (Maximum number of delegates 50).

Time: 07.15. Departure from Kalmar by bus from a central point, to be announced later. Tour ends at 16:30 on the same day in Kalmar.



The visit will take you to the peninsula of Simpevarp, which is approximately 100 km north of Kalmar and will give you the opportunity to visit the facilities run by the Swedish Nuclear Fuel and Waste Management Company Co (SKB) as well as Oskarshamn Nuclear Power Plant Unit 3.

Delegates must choose between visiting Oskarshamn Nuclear Power Plant Unit 3 or the Central Interim Storage for Spent Nuclear Fuel, Clab, in the morning. All participants will visit Äspö Hard Rock Laboratory in the afternoon.

Option 2:

**TWO-DAY TRIP TO FORSMARK'S, STUDSVIK'S AND KSU'S FACILITIES,
THURSDAY 31st MAY, TO FRIDAY, JUNE 1st, 2012
(Maximum number of delegates 50)**

Time: Departure 31st May from Kalmar by bus at 07:30.

Tour ends on June 1st. The bus will drop you off at Arlanda airport at 15:00 or the Stockholm Central Station (centre of Stockholm) at 16:00.

This 2-day trip will take you through the southern part of Sweden by bus and up to Forsmark Nuclear Power Plant, approximately 550 km north of Kalmar.

During this tour you will have an opportunity to visit Studsvik Nuclear AB, Forsmark Nuclear Power Plant Unit 3, KSU (Sweden's nuclear training and safety centre) and the Swedish Nuclear Fuel and Waste Management Co (SKB). During the tour you will learn more about nuclear power and nuclear waste management in Sweden as well as do some sightseeing in southern Sweden.

Delegates must choose between visiting Forsmark Nuclear Power Plant Unit 3 or a combined visit to SKB and KSU.

Option 3:

TOUR OF OLKILUOTO NUCLEAR POWER PLANT AND THE ONKALO WASTE FACILITY, FRIDAY, JUNE 1st, 2012

(Maximum number of delegates 20)

Time: Departure by bus from the harbour of Turku or Hotel Marina Palace, Turku at 07:30, June 1st.

Tour ends: after 20:30 in Turku, on the same day.

This visit will take you to Sweden's eastern neighbour, Finland, the Finnish nuclear power plant operator, TVO, and the nuclear waste management company, Posiva. You will start your tour at the visitors' centre at Olkiluoto where different projects will be presented. You will also visit the construction site of the high-level waste storage facility (ONKALO), the Olkiluoto Unit 3 reactor construction site and the repository for low and medium level operational waste.

Note: For this trip, you need to make and pay for your own travel arrangements from Sweden to Turku, Finland as well as accommodation in Turku. Free transport to and from Olkiluoto will be provided from the harbour of Turku or the Hotel Marina Palace in Turku. Since the visit starts at 07:30 on June 1st and ends late in the evening of the same day, when you make your travel arrangements, you should count on having to spend two nights in Turku: the night of May 31st and of June 1st.

Registration Fee

The registration fee of SEK 2,500 covers the organisation of the Congress, participation in the programme, technical visits (apart from travel arrangements and accommodation for Finland) conference materials and folder, the Opening Reception and Buffet Dinner, the Gala Dinner, lunches as well as refreshments and snacks. For Swedish delegates: VAT is not included in the conference fee.

Please note, the registration fee does not include:

- ❖ The cultural event on May 28th. The extra charge is: SEK 800
- ❖ Accommodation during the Congress. All hotel charges are to be paid by the delegate directly at the hotel (see also below)
- ❖ Travel to and from Turku, Finland as well as accommodation for the technical visit to Olkiluoto 3, Finland, May 31-June 1.

The registration fee and applicable other fees must be received prior to attending the Congress.

Hotel Bookings

Hotel bookings can be made on the online registration form. A selection of hotels and rates charged is provided on the form. Hotel charges are to be paid by the delegate directly at the hotel.

Terms for Cancellation and Refund of Registration Fee and Charges

- Before April 1st, 2012: The amount paid by the delegate less SEK 500 to cover administrative costs.
- Before April 20th, 2012: The amount paid by the delegate less 50% to cover administrative costs.



- After April 20th, 2012: No refund will be given.

In the event that a delegate who has already paid the registration fee and other applicable fees is unable to attend the Congress for unforeseen reasons, it is possible for a replacement delegate to attend the Congress. All replacements must be notified to the Congress Agency by email or post. No refund will be issued in such a case and the delegate and the replacement delegate shall arrange payment between themselves. Replacements are not allowed for technical visits.

Cancellation requests will be valid only if addressed in written form to the Congress Agency by email.

No refunds will be given in the event of conditions beyond the Congress organisation's control such as, but not limited to, war, strikes, fires, floods, and acts of God.

By completing the online Congress registration, you agree to be bound by the terms of registration and cancellation.

14. Visas

All visitors to Sweden and Finland must have a valid passport. Some foreign nationals require a visa to enter Sweden and Finland. Check with the Swedish and Finnish embassies or consulates in your country whether or not you need a visa to Sweden and Finland.

Please consider that visa applications should be made well in advance of the Congress since visa processing may take some time.
